2.2. This guide has been prepared to provide information about the Foreign Student Placement System (ADÜYES) implemented by Aydın Adnan Menderes University for the **2025-2026** academic year.

2.3. Detailed and up-to-date information regarding application quotas, quota requirements, explanations, accepted exam results, tuition fees, and placement results can be found on the <http://yes.adu.edu.tr> website. **Announcements to be made on this address are official notifications for the candidates.**

2.4. Applications made in person or by mail outside the specified application period will not be accepted.

2.5. Applying to ADÜYES indicates that the candidate accepts all the provisions stated in this guide and on the relevant website.

2.6. ADÜYES is used for applications to associate and/or bachelor degree programs at Aydın Adnan Menderes University and cannot be used for transfer applications (vertical or lateral) and/or graduate studies.

2.7. In ADÜYES applications, candidates' declarations regarding whether they meet the application conditions and the application documents they upload to the system are taken into consideration. Candidates who have been placed in a program by applying to the placement system with **false or incomplete declarations** and/or **false/fake documents**, even if they have completed their registration or are still studying, will be dismissed from the university.

2.8. Aydın Adnan Menderes University is not responsible for issues related to scholarships, living expenses, accommodation, visa, and residence permits in Türkiye for foreign students.

## 3. APPLICATION REQUIREMENTS

3.1. Candidates who meet the following conditions can apply for the international student admission quotas:

A) On condition that applicant international students are in their last year of high school or graduated from high school;

1) Those who are foreign nationals, (provided that those who are studying in

secondary education institutions (high schools) in Türkiye have enrolled before the 2022-2023 academic year [except for embassy schools, international private education institutions included in the MOBIS system and foreign nationals brought to Türkiye within the framework of the project carried out by the Ministry of National Education of Türkiye]),

2) Those who are Turkish citizens by birth, but acquired permission to leave Turkish citizenship from the Ministry of the Interior and holders of the Blue Card issued upon request to those who have renounced their Turkish citizenship (provided that those who are studying in secondary education institutions (high schools) in Türkiye have enrolled before the 2022-2023 academic year) (According to the provision in Article 7 of the 5901 Numbered Turkish Citizenship Law “(1) those who were born in Türkiye or abroad to a Turkish citizen mother or father within a conjugal union are Turkish citizens by birth”. Therefore, applicants as international students are advised to read the aforementioned law),

3) Those who are foreign nationals by birth but have acquired Turkish citizenship later and therefore hold dual citizenship (provided that those who are studying in secondary education institutions (high schools) in Türkiye have enrolled before the 2022-2023 academic year),

4) Turkish nationals who completed their entire secondary education (high school) in a foreign country other than the TRNC (including those who completed their entire secondary education (high school) in a foreign country other than the TRNC in Turkish schools opened under the auspices of the Ministry of National Education),

5) Citizens of the Turkish Republic of Northern Cyprus (TRNC), who reside in the TRNC and have completed secondary education in the TRNC and have GCE AL (General Certificate of Education Advanced Level) results; and those who have been enrolled in foreign high schools abroad between 2005-2010 and have or will have GCE AL results or Citizens of the Turkish Republic of Northern Cyprus (TRNC) who have completed their entire secondary education in foreign high schools and have TR-YÖS results.

B) Candidates whose applications **will not be accepted** are listed below:

1) Those who are Turkish citizens and have completed all their secondary (high school) education in Türkiye or the TRNC,

2) Those who are TRNC citizens (excluding those who have completed their entire secondary education (high school) at TRNC high schools and have GCE AL exam results, those who enrolled and studied in colleges and high schools in other countries between 2005-2010 and have/will have GCE AL exam results, or those who are TRNC citizens and have completed their entire secondary education (high school) in a foreign country and have TR-YÖS results),

3) Dual nationals defined in item A, clause 2, whose first nationality is Turkish at birth (except those who meet the conditions in item A, clause 4),

4) Dual nationals whose one nationality is TRNC (except those who have completed

their secondary education (High School) in the TRNC and hold GCE AL exam results; those registered and educated at colleges and high schools in a different country between 2005-2010 and have or will have GCE AL exam results or those who are citizens of the TRNC and have completed their secondary education (high school) in a foreign country and have TR-YÖS results),

5) Those with Turkish citizenship who have studied in a foreign high school in Türkiye and schools within the structure of Embassies in Türkiye or those stated in the clause 2 of Article A defining Turkish citizens by birth with dual citizenship,

6) TRNC citizens and those who renounced Turkish citizenship/Blue Card holders and foreign nationals (except for embassy schools, international private education institutions included in the MOBİS system and foreign nationals brought to our country within the framework of the project carried out by the Ministry of National Education) enrolled in secondary education institutions in Türkiye as of the 2022-2023 academic year.

#### **4. APPLICATION PROCEDURES**

**4.1.** ADÜYES applications will be made through the <https://yes.adu.edu.tr> website within the dates specified in the ADÜYES Placement Calendar. After this period, the application system will automatically close. Applications made in person or by mail outside the specified application period will **not** be accepted.

**4.2. Candidates who meet the application requirements** specified under the Application Requirements section above can apply to ADÜYES by using only one of the exam results or diploma grades listed in the Accepted Exam Results section under the Application Procedures menu on the <https://yes.adu.edu.tr> website. Candidates make their applications by choosing one of the methods stated below under the Application Methods and Examinations part of this guide.

**4.3.** Candidates check the ADÜYP scores by entering the exam score/diploma result from the 'ADÜYP Calculation' menu under the 'About ADÜYES' menu on the ADÜYES website <https://yes.adu.edu.tr>, then choose the highest exam result/diploma score and complete the application with one of the methods listed in article 5 below.

Candidates must check the validity date of their documents and then upload them to the system. Otherwise, the applications of those candidates will be rejected as the documents that do not comply with the validity dates in the Accepted Exam Results and Diploma Grade List under the Application Procedures menu will be considered invalid.

**4.4.** Applications can be made either in Turkish or English. If the original documents required for the application are not available in Turkish or English, candidates must upload official Turkish or English translations of the documents to the system at each step where the document is requested. Candidates who do not upload notarized official Turkish or English translations of the original documents that are not in Turkish or English to the system are considered to have made an application with a missing document and thus their applications will be rejected.

**4.5.** Candidates must apply to ADÜYES between the dates specified in the ADÜYES Placement Calendar by clicking on the “Log In” tab on the ADÜYES website section on the ADÜYES website to apply to ADÜYES. For example, a candidate who was born a French citizen and later acquired Turkish citizenship and is dual national must declare their

nationality as French) and contact information (email address, phone number) to register in the system and create a user account. The email address provided by the candidate must belong to the candidate themselves, and each candidate must use only one email address. An automatic email is sent to candidates who register in the ADÜYES system. Candidates log in to the <https://yes.adu.edu.tr> website using the **Candidate Number** and **Password** provided in the email. The “**Candidate Number**” must be specified in all correspondence with ADÜ. Emails and petitions without the Candidate Number will not be processed. To log back into their **User Account**, candidates click on the “Log In” tab again and enter their **Candidate Number** and **Password**. After logging into the Application System, candidates carefully review this Guide and the Application Calendar available in the ADÜYES Application System, then proceed by selecting one of the application methods available on the candidate portal.

## 5. APPLICATION METHODS AND EXAMINATIONS

**5.1.** Candidates can apply by choosing **only one** of the application methods below. It is not possible to apply using more than one of the methods below.

If a candidate is found to have made **multiple applications** using different methods, all of their applications **will be deleted**.

**5.1.1. Method 1 / Turkish Higher Education Examination for Foreign Students (TR-YÖS):** Candidates can apply with a TR-YÖS score obtained from the TR-YÖS exam conducted by ÖSYM, provided that they have a TR-YÖS Score above 100. The TR-YÖS exam is valid for two (2) years from the date it is taken.

The conversion formula for this exam is available on the ADÜYES website under the Accepted Exam Results List menu in the Application Procedures section. The conversion formula for the TR-YÖS Score is applied to the candidate's TR-YÖS Score entered on the ADÜYES website under the Accepted Exam Results List menu in the Application Procedures section. 100% of the converted score is used as ADÜYP.

Candidates can calculate their ADÜYP score on the ADÜYES website under the same menu.

**5.1.2. Method 2 / TRNC GCE AL:** Candidates who have completed their secondary education at KKTC high schools and are KKTC nationals may apply with their KKTC GCE AL exam results certificate. There is no time limit for the validity of the KKTC GCE AL exam.

The letter grades on the exam result certificate are converted to points as follows: A\*=140, A=120, B=100, and C=80. Candidates must select a total of four (4) subjects, with at least two (2) at the A (Advanced Level) level and at least two (2) at the A level or AS level (Advanced Subsidiary Level).

The first subject must be A-level Mathematics, and the second subject can be any A-level subject. The third and fourth subjects can be either A-level or AS-level subjects.

In letter grade point calculations, a coefficient of 3.5 is applied to the first subject, 1 to the second subject, and 0.5 to the third and fourth subjects. The sum of the points calculated in this way is the Candidate GCE AL Score. Candidates with a Candidate GCE AL Score of at least **four hundred and forty (440)** may apply for placement.

The candidate's placement score is the ADÜYP obtained as a result of the conversion process. The base score for the calculated ADÜYP is **forty (40)**, and the maximum score is one hundred (100).

The minimum and maximum scores for this exam, its validity period, and the conversion formula are available on the ADÜYES website under the “Accepted Exam Results List” section within the “Application Procedures” menu. The conversion formula for the relevant exam, available under the

“Accepted Exam Results List” tab in the “Application Procedures” menu on the ADÜYES website, is applied to the KKTC GCE AL score entered by the candidate. The converted score obtained is used as **100% of the ADÜYP**. The candidate can calculate their ADÜYP score using the “ADÜYP Calculation” tab under the same menu on the ADÜYES website.

## 6. ADÜYES APPLICATION

**6.1.** Candidates who have decided which of the two different application methods mentioned above in article 5 they will use must complete their applications by following the steps below on the <https://yes.adu.edu.tr> website within the dates specified in the ADÜYES Placement Calendar:

- 1) **Entering the ADÜYES System:** Candidates who have decided which application method to use log into the <https://yes.adu.edu.tr> website within the application period by clicking on the 'Login' button.
- 2) **Candidate Application Process:** Candidates start the application process by clicking the "APPLY" button on the ADÜYES menu on the homepage. Candidates must carefully read the warnings that appear during the application steps.
- 3) **Entering Information about the Candidate’s Application Method and Uploading Documents:** Candidates select from the list according to the exam result or diploma grade they wish to apply with. They fill in the required information on the screen that comes up according to the selection they make and upload valid documents following the information entered. It is highly necessary to pay attention to the validity date of the documents, otherwise, the application of the candidate is rejected.
- 4) **Entering Candidate Information and Uploading Documents:** Candidates fill in the requested information on the screen and upload valid documents compatible with the information they have entered. It is crucial to pay attention to the validity date of the documents, otherwise, the application of the candidate is rejected.
  - a) **Uploading of Photograph:** Candidates who enter the candidate portal upload their portrait photos taken within the last 6 months through the candidate photo upload area. The quality of the photograph is explained in detail in the uploading part on the candidate portal.
  - b) **Uploading of Identity Document:** Candidates must upload their identity document in a manner in which all of it is visible and as an image file to the Upload Identity Documents menu. The identity document to be uploaded must be one of the documents found only in the identity document types options on the candidate portal. The identity document to be uploaded must contain a photo of the person, and the writings must be legible and clear. Candidates must upload their identity card with a visible **expiry date** on it. Applications of candidates whose ID validity cannot be confirmed, expired or will expire before the

exam date, and/or who upload identity cards (e.g., passport) of their first-degree relatives (parents) **are not accepted**.

- c) **Citizenship Status:** Candidates must choose the appropriate citizenship status by reading the information about the citizenship status on the screen. This selection is accepted as a declaration and constitutes the basis for the placement processes. Candidates who have been placed in a program by applying to the placement system **with false or incomplete statements and/or false/fake documents**, even if they have completed their registration or are still studying, will be dismissed from the university.
- 5) **Submitting Application:** Candidates complete their applications by declaring that the information they enter and the documents uploaded are valid and belong to them. The responsibility for the uploaded documents and information belongs to the candidates. Documents and information cannot be changed after the application has been submitted.
- 6) **Control of Application:** Documents and information of candidates who complete the application steps are examined by the Document Control Commission. Applications of candidates, information, and uploaded documents of whom do not match, are directed to the candidate application screen to upload the missing document or correct the inaccurate information. Candidates can follow their application status on the candidate portal on the dates specified in the exam calendar.
- 7) **Completing Missing Documents or Information:** Candidates can log into the ADÜYES system on the dates specified in the ADÜYES Placement Calendar and update their documents and information. Applications of candidates who do not update their information until the end of the completing missing documents/information period are rejected. Applications of candidates whose information and uploaded documents do not match in the missing document completion period are rejected by the commission. ADÜYP calculation and placement of candidates whose applications are rejected will not be made.
- 8) **Application Approval:** Applications of candidates who have successfully completed all the above steps and uploaded valid documents and information will be approved.
- 9) **Calculation of ADÜYP:** ADÜYP calculations are made for candidates whose applications have been approved. The ADÜYP calculation formula is available on the Accepted Exam Results List menu under the Application Procedures menu on the <https://yes.adu.edu.tr> website. Following the announcement of the final ADÜYP results of the candidates according to the placement calendar, candidates make their preferences specified in the 7th article below.

ADÜYP calculation and placement are not made for candidates whose applications are rejected.

## 7. PREFERENCES

**7.1.** Following the announcement of the final ADÜYP on the date specified in the ADÜYES Placement calendar, candidates can make their program preferences using this score. Program preferences can be carried out by candidates on the dates specified in the ADÜYES Placement calendar on the <https://yes.adu.edu.tr> website under the 'Candidate Main Page'. Candidates can choose a maximum of ten different programs. Essential information and minimum acceptable points, special conditions, and explanations are available on the preference page. Candidates are obliged to investigate the terms of the program they will prefer. Candidates who make and approve their preferences cannot change their preferences later. Therefore, candidates need to be careful when confirming their preferences.

**7.2.** Preferences of candidates who make their choices but do not and/or forget to approve their applications are automatically approved by the system after the preference period ends. Candidates are subject to be placed according to these preferences.

**7.3.** Candidates **are not allowed** to change their preferences in any way after the end of the preference period.

## 8. EVALUATION AND PLACEMENT

**8.1.** Placement in quotas is based on the preferred program quota, ADÜYP score, preference order, minimum score set for the preferred program, and the provisions of Article 8.3 of this guide.

**The number of candidates from the same country who are eligible to register cannot exceed 20% of the total quota for the relevant program. The 20% limit is not taken into account in additional placement procedures.**

In situations of equality, priority shall be given to the candidate with the lower age. In case of the same age, priority will be given to the candidate whose graduation date is closest to the application date. If the graduation date is the same, priority will be given to the candidate whose application date is earlier.

**8.2.** Candidates who have a minimum ADÜYP score of 40 can apply for programs that admit students through a special talent examination. For the placement of students in the Medicine and Dentistry Programs, the ADÜYP score **must be at least 75**. The evaluation of applications made to units that admit students through a special talent examination will be carried out according to the special talent examination application registration and acceptance guidelines of the relevant units. **The number of applicants from the same country who are eligible to register cannot exceed 20% of the program quota.** In the event of a tie, priority is given to the younger applicant. If the applicants are of the same age, priority is given to the applicant whose graduation date is closest to the application date. If the graduation dates are the same, priority is given to the candidate with the earliest application date. **A student admitted to a program that has a special talent exam will not be registered if they fail the special talent exam.**

**8.3.** In accordance with the Higher Education Council's letter dated 25/07/2019 and numbered 54050, within the scope of Article 45/f of the Higher Education Law numbered 2547, amended by Law numbered 6287, and regarding the International Students Admission Principles determined by the Higher Education Council, candidates who are eligible to apply for international student admission quotas and those who have the opportunity to apply under the Turkish Citizenship Law and those

who have Turkish citizenship by birth but lost their Turkish citizenship by obtaining permission from the Ministry of Interior, those who document that they have a Blue Card issued upon request, those who continued their secondary education abroad before 01/02/2013 and completed the last three years of their secondary education in a foreign country other than the TRNC, or those who completed all of their secondary education in foreign high schools (excluding TRNC high schools), those with dual citizenship, one of which is Turkish, can apply for international student admission quotas within the framework of the criteria determined by universities. For the placement of students in the Teacher Education, Medicine, and Dentistry programs in the international student admission quotas accepted by the Senate, the quota for these candidates in the related fields cannot exceed 10%.

**8.4.** The university is free to admit as many students as stated in the quota or less.

**8.5.** Placement results will be announced on the ADÜYES tab on the Candidate Home Page of the <http://yes.adu.edu.tr> website on the date specified in the ADÜYES Placement Calendar.

**8.6.** Acceptance letters for candidates who have gained the right to register for associate and undergraduate programs will be available to download on the <https://yes.adu.edu.tr> website on the ADÜYES menu on the Candidate Portal.

**8.7.** Candidates who are eligible to register shall register between the dates specified in the ADÜYES Placement Calendar in accordance with the provisions of Article 9 of the guide.

## **9. REGISTRATION PROCEDURES**

Placement results will be announced on the ADÜYES menu on the Candidate Portal on the <https://yes.adu.edu.tr> website on the dates specified in the placement calendar.

### **9.1. Documents required for registration:**

- a) The placement result document downloaded from the ADÜYES website (<https://yes.adu.edu.tr>) and original additional documents specified in its content and notarized Turkish translations of these documents,
- b) Original High School Diploma or original graduation document and a notarized Turkish translation of this document,
- c) ‘Equivalency Document’ of high school diploma or graduation document certifying the equivalency of the applicant’s diploma to that of Turkish diplomas from a Turkish Embassy or Consulate in the student’s own country or from the Turkish Ministry of Education,
- d) Original transcript of records and its notarized Turkish translation,
- e) Original passport and its notarized Turkish translation,
- f) Bank statement showing that the tuition fee has been paid to the relevant bank,
- g) 6 biometric passport-size photographs (4.5cm x 6cm) taken within the last 12 months,
- h) For departments with Turkish education, a Turkish Language Proficiency Level Certificate; for departments with English education, an English Language Proficiency Level Certificate accepted by ADÜ School of Foreign Languages;

for departments with French education, a French Language Proficiency Level Certificate accepted by ADÜ School of Foreign Languages; for departments with German education, a German Language Proficiency Level Certificate accepted by ADÜ School of Foreign Languages (if available),

- i) Original Certificate of Identity Register Copy. This document is mandatory for those who have double nationality- one of which is Turkish- and must show the nationality registration in detail),
- j) Health Report taken from a general state hospital in Türkiye for students to study in programs requiring a health report for registration, as shown in the quota conditions,
  - i. 1) Signed Declaration of Financial Security Form,
- k) Document showing that the student has registered with the General Health Insurance (GSS) provided by the Social Security Institution.

**9.2. Registration must be carried out by the candidate in person or by a representative who has been given a power of attorney** with a notarized power of attorney in case the candidate cannot apply in person at the Student Affairs Office of the faculty/school/vocational school to which admission has been gained during working hours (08:00-17:00).

**9.3.** The documents of candidates who have come for registration will be checked.

**9.4.** The candidate will be given information on the necessary tuition fees and payment methods.

**9.5.** Payment of tuition fees should be made through the bank machine of the bank with which our University is affiliated by choosing the education payments screen, then Aydın Adnan Menderes University and entering personal identity information.

**9.6.** The bank slip showing payment of the tuition fee should be submitted with the other documents necessary for registration to the relevant student affairs office.

**9.7.** After all registration documents have been received, the student's registration will be completed, and the student will be given a student certificate.

## **10. ADDITIONAL PLACEMENT**

**10.1.** The quotas for Additional Placement, the conditions for the quotas, and the Additional Placement Calendar will be announced on the <https://yes.adu.edu.tr> website on the date specified in the ADÜYES Additional Placement Calendar. The conditions specified in this guide are also valid for Additional Placement; a separate guide will not be published.

**10.2.** Candidates who did not get placed in any program as a result of the first placement procedures can apply for Additional Placement by completing the Additional Placement Application Procedures within the periods specified in the ADÜYES Additional Placement Calendar. For this, they must create a new application record in the ADÜYES Application System. Applications for Additional Placement from within Türkiye and abroad will be made through the <https://yes.adu.edu.tr> website. Applications made outside the specified period will not be accepted.

**10.3.** The university is free to fill the quotas or not in Additional Placement procedures.

**10.4.** Additional Placement results will be announced on the <https://yes.adu.edu.tr> website on the ADÜYES menu on the Candidate Portal on the date specified in the ADÜYES Additional Placement Calendar.

**10.5.** Candidates who have gained the right to register for associate and undergraduate programs through Additional Placement will be able to receive their acceptance letters on the <https://yes.adu.edu.tr> website on the ADÜYES menu on the Candidate Portal.

**10.6.** Candidates who have gain the right to register through Additional Placement must do so according to the information given in Article 9 of this guide on the dates specified in the ADÜYES Additional Placement Calendar.

## **11. LANGUAGE REQUIREMENTS**

### **11.1. Turkish Programs**

(1) Candidates who will register for programs where the medium of instruction is Turkish must certify their Turkish proficiency level at the time of registration. The Turkish proficiency levels of those placed in programs will be determined according to;

- a) The Turkish Language Proficiency Certificate issued by ADÜTÖMER,
- b) The Turkish Language Proficiency Certificate issued by the Yunus Emre Institute.

(2) Candidates who have completed their entire secondary education in Türkiye, who have completed their secondary education in Turkish high schools abroad affiliated with the Ministry of National Education of Türkiye, or who have graduated from a higher education diploma program (associate/bachelor/graduate) taught 100% in Turkish at home or abroad do not need to provide a Turkish proficiency certificate.

(3) Candidates placed in programs where the medium of instruction is Turkish and who have at least C1 level Turkish proficiency, as well as those placed in programs taught in a foreign language and who have at least B1 level Turkish proficiency alongside their foreign language proficiency, can start their education in the program they have been placed in.

(4) Students must certify their Turkish proficiency level at the time of registration. Students who cannot provide a Turkish proficiency certificate or whose Turkish proficiency level is insufficient to start education in the program they have been placed in must take the Turkish Proficiency Exam conducted by ADÜTÖMER on the date specified in the academic calendar to determine or improve their proficiency level.

(5) Students whose Turkish proficiency level is below the required level must enroll as a Turkish Preparatory Class Student in the unit they are registered in for a one-year Turkish Preparatory Class education and will be directed to ADÜTÖMER. Those who reach the required Turkish proficiency level during this period will be reported by ADÜTÖMER to the unit they are registered in and will start their education in the program they have been placed in. Students who cannot reach the required Turkish proficiency level at the end of the first year will continue their registration as a Turkish

Preparatory Class Student in the program they are registered in and continue their education at ADÜTÖMER. Students who fail to reach the required Turkish proficiency level at the end of the second year will be dismissed from the university.

(6) Students placed in programs where the medium of instruction is entirely a foreign language must meet the required language proficiency condition for the language of instruction in the program they have been placed in, as well as have at least B1 level Turkish language proficiency.

## **11.2. English, French, German Programs**

(1) Foreign students enrolled for the first time in programs with a compulsory foreign language preparatory class must apply to the School of Foreign Languages (YDYO) Directorate for their foreign language exemption requests within ten (10) working days before the semester course start date of the unit they have enrolled in.

(2) Students who meet any of the following conditions are exempt from the preparatory class and can start their education in the programs they have gained admission to. These conditions are:

a) Achieving a minimum score of fifty (50) out of one hundred (100) points on the Foreign Language Proficiency Exam (YDYS) for students enrolled in associate programs, a minimum score of seventy (70) out of one hundred (100) points for students enrolled in bachelor programs, and achieving the minimum score required by the institute for students enrolled in graduate programs.

b) Having completed their secondary education in secondary education institutions attended by the nationals of that country where the foreign language used as the medium of instruction is the native language.

c) Achieving the minimum passing score in any of the national or international exams accepted by the Senate and listed in the equivalence table at the end of the Aydın Adnan Menderes University Foreign Language Education Directive within the last five (5) years,

d) Successfully completing the preparatory class of a higher education institution whose equivalency is accepted by the Interuniversity Council with the approval of the YDYO Administrative Board.

(3) Except for passing the YDYS, exemption from the preparatory class will be decided by the YDYO Administrative Board.

(4) Students who do not meet at least one of the exemption conditions attend the preparatory class.

(5) There is no make-up exam for students who do not take the YDYS held at the beginning of the academic year and they are placed in the lowest level groups.

(6) Students who fail the relevant language proficiency exam or do not provide a valid language certificate must enroll in the one-year Foreign Language Preparatory Class conducted by the ADÜ School of Foreign Languages.

(7) Detailed information about the compulsory language certificates required for certain courses in English, French, and German programs is provided below:

**English Language and Literature:** International students enrolled in this program are required to submit at least a B2 level Turkish Certificate from ADÜTÖMER for some compulsory courses (e.g., the Translation I course

coded IDE221). Obtaining this language certificate is mandatory for the compulsory courses required for graduation. For the courses offered in this program, see <http://akts.adu.edu.tr>.

**French Language and Literature:** International students enrolled in this program are required to submit at least a B2 level Turkish Certificate from TÖMER for some compulsory courses (e.g., the English-Turkish Translation I course coded IDE403). The equivalence of these certificates is determined by ADÜTÖMER. Obtaining this language certificate is mandatory for the compulsory courses required for graduation. For the courses offered in this program, see <http://akts.adu.edu.tr>.

**German Language and Literature:** International students enrolled in this program are required to submit at least a B2 level Turkish Certificate from ADÜTÖMER for some compulsory courses (e.g., the Translation A/T I course coded ADE209). Obtaining this language certificate is mandatory for the compulsory courses required for graduation. For the courses offered in this program, see <http://akts.adu.edu.tr>.

**English Language Teaching:** International students enrolled in this program are required to submit at least a C1 level Turkish Certificate from ADÜTÖMER for some compulsory courses (e.g., the Translation course coded ENT403). Obtaining this language certificate is mandatory for the compulsory courses required for graduation. For the courses offered in this program, see <http://akts.adu.edu.tr>.

## 12. TUITION FEES

**12.1.** The semester tuition fees for the 2025–2026 Academic Year are available on the <https://yes.adu.edu.tr> website under the Program Quotas section. If there are any changes in the lists attached to the Presidential Decree regarding the subject, necessary updates will be made.

**12.2.** Before making a tuition fee payment, the candidate must apply to the Student Affairs Office of the faculty/school/vocational school where they have been placed to get information about the tuition fee amount and payment methods.
